#### **HEALTHCARE IS IN NEED OF A SOLUTION**

Thirty-three percent of Americans have difficulty getting timely appointments for routine care. Seventy-three percent have difficulty making timely

doctors' appointments, getting phone advice, or receiving after hours care. When they finally get in to see the doctor, half a day is spent away from work and the average face-to-face time is only three to five minutes. According to the National Coalition on Health Care, in 2007 the total national healthcare expenditures increased by 6.9% to \$2.3 trillion or \$7,600 per person with expected increases

reaching \$4.2 trillion in 2016. Also in 2007, the Kaiser Family Foundation and the Health Research and

Educational Trust reported that employer health insurance premiums increased by 6.1%-two times the rate of inflation-while the average employee

> contribution to company-provided health insurance has increased more than 143% since 2000. Average out-of-pocket costs for physician and hospital visits rose 115% during the same period. As healthcare costs continue to rise, organizations are looking for smart, effective ways to reduce their benefit-related costs. As a result, there has been an increased focus on technology to connect

patients to different modes of care, such as phone consultation and virtual encounters.

A recent Hewitt study showed that 63% of the 450 major U.S. employers surveyed plan to take more aggressive steps to improve their employees' health and productivity, targeting the root of the issue: the interactions between doctors and patients.

MD Direct 24/7 offers a value-added benefit and reduces healthcare costs through a simple solution that gives employees and members on-demand access to quality care from the convenience of their home or office, as opposed to more expensive and less productive settings like an urgent care center or emergency room (ER). Our national telehealth network of physicians is the largest and most highly credentialed in the industry today-with U.S. boardcertified, licensed doctors. Our physicians use electronic health records and phone consultations to diagnose, recommend treatment, and write short-term, non-DEA-controlled prescriptions, when appropriate. MD Direct 24/7 is not designed to replace an employee's or member's primary care physician. It simply allows them to resolve their routine medical issues at a fraction of the cost and time of visits to urgent care centers, ER, or doctors' offices.

The MD Direct 24/7 physician calls in a prescription for an antibiotic to your local pharmacy and you pick it up on the way to work. Problem solved in less than an hour, for a fraction of the cost. And you never missed a day of work.

When one of your employees or members has a medical issue, he or she simply calls 1-800-679-0727 to address any health concerns. The medical associate answering the phone will complete a medical history disclosure prior to initiating the consultation than attempt to resolve the health concerns.



### Doctor Responds .. to Patient



A board-certified physician who is licensed in the employee's or member's state receives the request and reviews their personal EMR through MD Direct 24/7's physician portal. We allow up to three hours for the physician to call back the patient, however, in most of the cases, the doctor calls the patient back in less than an hour. The MD Direct 24/7 national average response time is 27 minutes.



#### Doctor Resolves Medical Issue



Based on the consultation, the doctor recommends the right therapy or treatment, or refers the patient to a PCP or ER if necessary. Ninety-One (91%) of MD Direct 24/7 members report that the MD Direct 24/7 physician resolved their medical issue.\*



#### Doctor Updates EMR



The doctor immediately updates the patient's EMR based on the consult. This information is available online through the patient secure EMR and is available for the patient and their PCP to review. All records are kept in accordance with HIPAA compliance.

At the end of every call, the doctor will ask if they have answered all the patient's questions, and will follow up to see if they were satisfied with the service.






